**From the North** – Take I-294 South to Willow Road. Exit West to Sanders Road (1st stoplight) and turn left. Proceed 1.3 miles to Milwaukee Ave and turn left. Proceed 1.2 miles to Zenith Drive and turn right. *The Aon Corporation is the white building at the end of Zenith Drive and the only building on the lane.*

**From the South** – Take I-294 North to Dempster Street. Exit East. Proceed over a mile to Greenwood Avenue and turn left. Proceed North on Greenwood Avenue approximately 1 mile to Milwaukee Avenue. Proceed Northwest on Milwaukee Avenue to Zenith Drive and turn left. *The Aon Corporation is the white building at the end of Zenith Drive and the only building on the lane.*

**From the East /Downtown Chicago** – Take I-90 West to I-294 North. Proceed North on I-294 to Dempster Street. Exit East. Proceed over a mile to Greenwood Avenue and turn left. Proceed North on Greenwood Avenue approximately 1 mile to Milwaukee Avenue. Proceed Northwest on Milwaukee Avenue to Zenith Drive and turn left. *The Aon Corporation is the white building at the end of Zenith Drive and the only building on the lane.*

**From the West** – Take I-90 East to I-294 North. Proceed North on I-294 to Dempster Street. Exit East. Proceed over a mile to Greenwood Avenue and turn left. Proceed North on Greenwood Avenue approximately 1 mile to Milwaukee Avenue. Proceed Northwest on Milwaukee Avenue to Zenith Drive and turn left. *The Aon Corporation is the white building at the end of Zenith Drive and the only building on the lane.*
